

How Medicare is affected by the overturn of the Defense of Marriage Act (DOMA)

The Supreme Court recently ruled that some parts of DOMA violate the Constitution and are therefore not legal. If you were legally married in a state that allows same sex marriage and you live in a state that recognizes your marriage, the federal government recognizes your marriage. This means there will be changes to Medicare and Social Security rules for same-sex spouses. How these rules will work depends on how Medicare and Social Security understand the Court's ruling. Parts of your Social Security and/or Medicare may change. These changes could include,

- You may be eligible for free <u>Part A</u> based on your spouse's working history.
- You may be able to use your spouse's group health plan coverage as <u>primary coverage</u>
 to Medicare, even after you turn 65. This means you may be able to <u>delay Part B enrollment</u>
 while your spouse is still working and for up to 8 months afterward without <u>penalty</u>.
- There may be changes to your <u>Part B and/or Part D premiums</u>.
- There may be changes to your eligibility for <u>Extra Help</u>.

States that allow same sex marriage are:

- Connecticut
- Delaware (as of July 1, 2013)
- District of Columbia
- lowa
- Massachusetts
- Maine
- Maryland
- Minnesota (as of August 1, 2013)
- New Hampshire
- New York
- Rhode Island (as of August 1, 2013)
- Vermont
- Washington
